- 3) Maximum age limit shall be 25 years as on **1st March 2017** are eligible to apply .Upper age limit is relaxable by 5 years for SC/ST, 3 years for OBC (OBC with Valid Non Creamy Layer Certificate) and 10 years for Persons with Disability (PWD) candidates.
- 4) Candidates belonging to SC/ST /OBC (Non-creamy layer) categories shall enclose the certificate issued by the competent authority in the prescribed format.
- 5) Cut off date for eligibility criteria - **1.03.2017**
