  - a) True copies of all certificates/mark sheets/testimonials regarding age, qualifications, caste.
  - b) Candidates who have passed prior to the year 2015, they should attach an Affidavit on Non judicial stamp paper duly attested by Magistrate or Notary Public to the effect that they have neither undergone Apprenticeship Training earlier nor have taken employment anywhere

- 3) Maximum age limit is 25 years as on **1st June 2017**. Upper age limit is relaxable by 5 years for SC/ST, 3 years for OBC (OBC with Valid Non Creamy Layer Certificate) and 10 years for Persons with Disability (PWD) candidates.
- 4) Candidates belonging to SC/ST /OBC (Non-creamy layer) categories shall enclose the certificate issued by the competent authority in the prescribed format.
- 5) Cutoff date for eligibility criteria i.e. age, qualification etc - **01.06.2017**

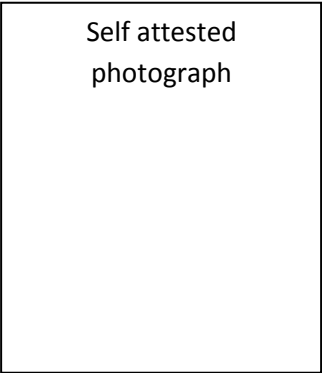
