It is informed that Members of Hindustan Copper Ltd in the ensuing 51st Annual General Meeting (AGM) convened on 27.9.2018 will inter alia consider Special Resolutions for the following:

- (i) To authorize the Board to offer, issue and allot equity shares through Qualified Institutional Placement to Qualified Institutional Buyers in terms of Chapter VIII of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009 whether by way of private placement or otherwise so that the total amount raised shall not exceed INR 1400 Crore or USD 217 Mn, whichever is higher.
- (ii) Consent of the Members to the Board of Directors for borrowing apart from temporary loan obtained from Company's Bankers in the ordinary course of business pursuant to Section 180(1) (c) of the Companies Act, 2013 provided that the total amount up to which money may be borrowed shall not exceed Rs. 1,500/- crore together with interest.
- (iii) Consent of the Members to the Board of Directors to offer, issue and allot, in one or more tranches, secured or unsecured non-convertible Debentures/ Bonds on private placement basis for amount not exceeding Rs.1500 crore.
- (iv) To authorize the Board of Directors, to create charge, mortgage or hypothecation on the assets of the Company in connection with borrowings by the Company pursuant to Section 180(1)(a) of the Companies Act, 2013.
